### FOREWORD

It has been another exciting year for the Association in 2024 with the rebrand to the Association for Laboratory Medicine providing us with an opportunity to increase our visibility and influence with NHSE and the CSOs of the devolved nations, and better reflect the breadth of our membership.



President Kath Hayden Following the change in UK government, LabMed submitted a response to the NHSE 10 year Health Plan consultation highlighting why laboratory medicine is fundamental to any shifts or innovations in healthcare delivery, and the role our members can play in leading transformation across England and the devolved nations.

As the Pathology Alliance, we have been working closely with the RCPath and IBMS, alongside other professional bodies, BIVDA and ABHI, to collaborate on areas of mutual interest in particular around workforce and sustainability. With our Green Champions, we inputted into the NHSE sustainable pathology workstream that has resulted in the inclusion of sustainability into the NHSE Network Maturity matrix for Pathology in recognition of its importance.

In my role on the Academy for Healthcare Science (AHCS) Professional Bodies Council, I have continued to support the push for amendments to legislation to enable clinical scientists to administer medicines using patient group "Our achievements are only possible with the on-going dedication of our members to improving clinical science and ultimately patient care." directions, plus consideration of enhancement to full prescribing rights, which has been raised with Wes Streeting, Secretary for State for Health and Social Care.

Highlights this year have been our excellent national and regional meetings. LabMedUK24 in Brighton opened with the International Award Lecture delivered by Octavia Peck-Palmer, president of the ADLM, speaking about how laboratory medicine can lead the way in translating data analytics to identify and eliminate health disparities; a timely reminder of the many weaknesses in the evidence used to develop our current guidelines.

This year importantly marked the 20th anniversary of the launch of Lab Tests Online UK which continues to attract ever increasing numbers of patients each month to this fantastic resource. We look forward to seeing this continue to grow.

For clinical and scientific updates, we were delighted to announce the launch of the renal resources page on our website, created by Anna Barton, LabMed's representative to the UK Kidney Association. This now provides easy access for members to the latest guidance on AKI, CKD and KFRE. The Lp(a) taskforce report was also published this year.

Our most notable achievement for 2024 was the successful renaming and rebranding of the Association. This rebrand has allowed us to broaden our engagement with a diverse community of scientists, clinicians, innovators and researchers.

We put our values at the heart of this rebrand and our commitment to sustainability and inclusivity has continued to grow, with initiatives such as the Green Champions group building on collaborations with NHSE, IBMS and RCPath. The expansion of our EDI network has ensured broader representation across our committees, embedding inclusivity into our work.

A highlight was the success of LabMedUK24 held in June in Brighton. Education and professional development remain at the heart of our purpose as an Association. We successfully launched the Learning Academy in March, offering digital learning resources tailored to trainee clinical scientists and those preparing for FRCPath exams. Thank you to Hazel Borthwick and Adrian Park for the huge amount of work they put into this.

The return of our Leadership and Management course in August and the Trainee day alongside the Freddie Flynn lecture at the National Audit Day in November, provided valuable development opportunities for our members. We continue to offer online training sessions for our Federation of Clinical Scientists (FCS). We have also been active on the global stage participating in a THET funded project to improve chemical pathology training in Ghana, Kenya and Nigeria led by the Royal College of Pathologists. Throughout the year we worked with regional chairs to improve the equity of access to bursaries, awards, and scientific meetings. A harmonised policy across regional committees has enabled us to offer free access to online and in-person scientific meetings plus 30 regional bursaries through a streamlined application process.

We began developing our next five-year strategy (2025-2030), kicked off with a strategy day in July. This plan will ensure that we continue to support our members effectively and contribute to advancements in laboratory medicine.

We entered into a new strategic partner with Roche Diagnostics and we look forward to developing our relationship with them over the next year. We also built a new partnership with Abbott's UNIVANTS of Healthcare Excellence awards gaining funding from them to bring the 2025 winners to LabMedUK25 in Manchester.

We finished the year on a high with the news that LabMed was selected by the EFLM and the IFCC to host EuroMedLab27 in London.

Thank you to all our members for your contributions and engagement throughout 2024. A special thank you to those directors who have finished their terms: Hazel Borthwick, director, Education, Training and Workforce Committee and Elizabeth Bateman, chair, Immunology Professional Committee.

Michael Murphy stepped down as co-editor-in-chief of the Annals. Thank you also to LTO editor Sally Stock and deputy LTO editor Kate Shipman who finished their terms.

# EDUCATION AND TRAINING COMMITTEE

The committee delivered its core aim of providing supplementary education for trainees addressing gaps in formal training programmes. Over the past year, we ran a successful LabMedUK24 training day as well as the trainees education meeting alongside the Freddie Flynn lecture at the Royal College of Pathologists. Thank you to Emma Walker for all her work convening the successful residential management course in Canterbury this year.

We awarded seven national education bursaries, totalling £3,000, which enabled members to attend LabMedUK24, the management training course and the Northwest Europe Immunoassay and Clinical Chemistry Siemens Customer Connect Forum.

The restructure of the Education, Training and Workforce Committee was completed. This included the formation of the Education and Training Committee and the Biochemistry Education Group, both of which held successful inaugural meetings. The Education and Training Committee also led on the association's response to the independent review of the National School for Healthcare Science led by Jane Dacre.

Thank you to Hazel Borthwick for her service as director of education, training and workforce from 2017 to 2024. Her leadership of the Learning Academy pilot and the recent committee restructure has laid a strong foundation for the future.

We warmly welcome Emma Stevenson (chair, Biochemistry Education Group) and Adrian Park (editor-in-chief, Laboratory Medicine Learning Academy) to the committee.

### LABORATORY MEDICINE LEARNING ACADEMY

Launched to all members in April 2024, the Learning Academy provides curated, on-demand digital learning to support continuous professional development. It features structured training modules, standalone lectures, webinars and a repository of self-guided learning materials.

In its first year, 1,342 association members were given access the academy. There were 619 enrolments across all available content, accumulating a total of 267 hours of active learning with an average completion rate of 51%.

A governance model was established, with Adrian Park appointed editor-in-chief to lead the Digital Learning Board, ensuring quality assurance and alignment with the association's goals.

# SCIENTIFIC AND CLINICAL PRACTICE COMMITTEE

A key highlight of the year was developing content for the Patient Centric Sampling conference in Liverpool, organised by SACP member and outgoing chair of the Pre-analytical Group, Sophie Hepburn, alongside member Karen Perkins. Patient-centric sampling is an emerging area in laboratory medicine and it was fantastic to see 87 delegates in Liverpool learning from both industry and NHS colleagues in February 2025.

The National Audit Committee held its ever-popular event, presenting audit findings on 15 November 2024. Delegate feedback was excellent. The membership responded to the following national audits in 2024:

- Audit on iron overload and HFE mutation (January 2024)
- Audit on diabetes mellitus (April 2024)
- Audit on Wilson disease (September 2024)
- Audit of the laboratory investigation of prostate-specific antigen (PSA) for the diagnosis and monitoring of prostate cancer (December 2024)



#### C Science Knowledge Hub

Work on the verification offering is reaching the pilot stage with members set to trial an R-based programme developed by member Ed Wilkes. Meanwhile, the paediatric reference range group, formed through member applications this year and led by Lesley Tetlow, has begun its work by examining TFTs using the indirect reference range method.

LabMed members also played a key role in the authorship and review of the recently published: *Standardising Lipid Testing and Reporting in the United Kingdom; A Joint Statement by HEART UK and the Association for Laboratory Medicine.* 

This year, we welcomed a new immunology representative, Ashleigh Rainey.

As this is my final year as director of scientific affairs, after 11 years on the committee, I would like to thank all the committee members I have worked with for their support.

### **RESEARCH AND INNOVATION GRANT**

In 2024 we awarded research and innovation grants to:

- Adam Pattinson: Novel biomarker strategies for risk assessment in kidney transplantation: a multi-omic approach
- Emma Miler: Evaluating the predictive value of FGF-23, NT-proBNP, and other biomarkers for poor outcomes in vascular surgery
- Lindsay Graham: Developing precision diagnostic approaches in steatotic liver disease using novel LC/MS phosphatidylethanol 16:0/18:1 quantification in a cohort of patients with Type 2 diabetes.

### LAB TESTS ONLINE UK

The 20th anniversary of Lab Tests Online UK was marked at LabMedUK24 in Brighton.

We engaged a specialist digital agency William Joseph to do some user research to help us plan future development of the website.

Connections from the NHS app to the site have increased, reinforcing Lab Tests Online's status as the leading patient resource for laboratory test information. The site saw 7.4 million users in 2024 – an impressive 23% increase from 2023, with the ten most accessed tests being white blood cells, HbA1c, FBC, red cell indices, cholesterol, haemoglobin, PCV, platelet count, red blood cell count and creatinine.

We extend our sincere thanks to Sally Stock (managing editor) and Kate Shipman (deputy editor) for their dedication in developing and maintaining the site. Thank you to both the RCPath and IBMS for their continued funding and support.

### ANNALS OF CLINICAL BIOCHEMISTRY

Overall, 2024 was another good year for the journal, with a healthy number of citations.

Journal Impact Factor (IF) for 2024 was 2.1 compared to 2.2 in 2023 ranking 17/30 in the Medical Laboratory Technology list.

The Clinical Sciences Review Committee (CSRC) has consistently provided a steady supply of high-quality reviews to the *Annals* and is also now providing support for consideration of best practice articles.

The time to final editorial decision has reduced to 32 days compared to 55 days for 2023. Time in production for manuscripts with the publisher fell from 20 days to 17.

The publisher re-tender process was completed and the contract awarded to Sage Publishing for the next five years from 2025.

Special thanks to the following new associate editors welcomed to the team during 2024: Tony Badrick, Graeme Greenfield, Vyanka Redenbaugh, Maduri Vidanapathirana and Hewa Warawitage Dilanthi, who each bring a wealth of publishing and professional experience to the *Annals*.

# MICROBIOLOGY PROFESSIONAL COMMITTEE

The committee's highlight of the year was hosting well-received sessions at both LabMedUK24 and the Federation of Infection Societies (FIS) conferences. Thanks to our previous successful involvement at FIS, our sessions at the 2024 conference in Liverpool were held in the main auditorium. Several hundred delegates attended and the feedback was overwhelmingly positive.

We collaborated with RCPath, the British Infection Association (BIA) and the Healthcare Infection Society (HIS) to produce guidance for departments and trusts looking to appoint consultant clinical scientists in microbiology and virology.

Our work with the National School of Healthcare Science (NSHCS) continues to shape the education and training of clinical scientists. We were approached by the Liverpool School of Tropical Medicine to advise on the re-launch of their parasitology courses, ensuring alignment with the STP curriculum and trainee needs.

We successfully appointed Umar Anjum as the Microbiology Professional Committee's (MPC) EDI representative. Meanwhile, the microbiology section of the online education platform has been strengthened with content from the sequencing in infection course. Our monthly online clinical case discussions have also been a success, with over 20 participants per session engaging in lively debate and Q&A.

We are also grateful to welcome Eleanor Finnie, Seshadri Vasan, Umar Anjum, Stuart Reid and Michael Perry to the committee.

# SUSTAINABILITY

The Green Champion Group was set up to promote sustainability in laboratory medicine, by engaging, educating and promoting awareness.

This year the group have been able to publish five articles on laboratory sustainability in *LabMed News* as well as published a Green Champions web form to collect examples of good practice allowing for the establishment of a comprehensive Environmental Sustainability Stakeholder database.

Green Champion members have also given 11 talks at national and international meetings to share our learning. We have also helped support the preferential selection of event venues with good sustainability credentials and created a sustainable events guidance document.

A major milestone this year was the creation of a unified bursary policy for regional committees, aligned with the national bursary. This move supports greater transparency and inclusivity and has already had a positive effect – improved communication around bursaries led to increased uptake in 2024. The data will be reviewed in the coming year to assess its full impact.

November saw the first-ever hybrid delivery of the National Audit Conference, broadening accessibility while preserving the benefits of in-person engagement. The Events and Conferences Committee continues to prioritise venues that can support hybrid delivery cost-effectively and is exploring options for filmed content to support hybrid and on-demand access.

Participation in the Science Council's EDI Forum has provided valuable insights, helping to inform new initiatives such as transitioning to an application-based process for honorary officer and committee roles. By promoting these opportunities more widely and sharing member stories, we aim to encourage a diverse range of applicants to step forward.

### FINANCE DIRECTOR'S REPORT

# The full details of the Association's 2024 accounts are available on our website

In 2024, we continued to strengthen the membership offer following our successful rebrand. Building on benefits introduced in 2023 – such as the mentoring platform, EFLM Academy membership, trade union training and the removal of fees for regional member meetings – we launched the Learning Academy, offering members free access to online learning. These ongoing improvements have contributed to steady membership growth, with a 4.2% increase in the fee-paying member category in 2024, and an 11.2% increase since 2020.

We made further improvements to our bursaries and grants, streamlining the application process and promoting them more widely. As a result, we awarded more national and regional bursaries and continued to support member-led research through our grants programme (totalling £32,549).

We had a successful year for events, with LabMedUK24 in Brighton delivering a higher surplus than in 2023. This was helped by a fully sold exhibition and a return to pre-pandemic levels of sponsorship. We also saw increased income across workshops and training, regional meetings and industry partnerships. Our simplified membership fee structure, introduced in 2023, has brought greater transparency, though it impacted our income slightly. In 2024, membership fees made up 28% of our total income (down from 30% in 2023). To help offset this, we agreed an above-inflation membership fee increase for 2025.

We invested in the capacity and expertise of our team in 2024, particularly to support learning and events. These staffing changes have enhanced our ability to deliver value for members and contributed to the successful implementation of new initiatives. Staff costs rose as expected, but we continued to reduce costs in other areas through careful supplier review and efficiency savings.

Towards the end of the year, we recruited Fen Sung as a non-executive director to strengthen Council's financial oversight and lead a review of our investment strategy. We also received news our bid to host EuroMedLab27 in London was successful.

We continue to maintain a strong financial position with reserves sufficient to support core operations for an extended period. Our long-term financial strategy remains focused on diversifying income streams, reducing risk and creating the flexibility we need to grow and innovate in the years ahead.
