

# Immunology Professional Committee Job Description for:

Consultant Clinical Scientist representative on the Royal College of Pathologists (RCPath) and Joint Royal College of Physicians Training Board (JRCPTB) Clinical Immunology & Allergy Specialist Advisor Committees SAC)

This role is to act as a liaison between the IPC and both the RCPath and the JRCPTB Specialist Advisory Committees for Clinical Immunology & Allergy. This individual will attend the RCPath and JRCPTB SAC meetings and IPC meetings. This role includes provision of input, oversight and feedback to the IPC of any decisions made in the JRCPTB SAC relating to the college examinations, clinical training pathway and Clinical Immunology & Allergy curriculums for both the ACI and ACLI medical training schemes; specifically, how these decisions may impact Clinical Scientists in training.

This position is for a minimum three-year term.

# **Purpose of role:**

- To facilitate communication and collaboration between the IPC and the RCPath and JRCPTB Clinical Immunology & Allergy SACs.
- Participate in the activities of the RCPath and JRCPTB SACs as a representative Consultant Clinical Scientist. The Clinical Immunology & Allergy SACs have a responsibility for matters, including the professional, clinical and continuing professional education functions at the RCPath. This includes reviewing latest research and considering its implications on the specialty, monitoring and considering workforce issues and developing and maintaining standards, clinical guidelines and best practice recommendations.
- Represent the point of view of the Clinical Scientist community with regards to matters relating to the Clinical Immunology & Allergy training curriculum at the JRCPTB SAC.

### **Requirements of role:**

Attendance at meetings of the Immunology Professional Committee.
This occurs at least twice a year. The Consultant Clinical Scientist
representative on the RCPath and JRCPTB SAC should prepare a
written report summarising their activities since the previous
meeting, to be circulated ahead of each meeting.



- Attend RCPath Immunology SAC meetings as the Consultant Clinical scientist representative for Immunology Professional Committee. These meetings are twice a year.
- Attend the JRCPTB meetings as the Consultant Clinical scientist representative from the perspective of the Clinical Scientists Immunology Professional Committee and provide liaison regarding the Clinical Immunology & Allergy curriculum.
- Have experience in training of Clinical Scientists and be familiar with the Clinical Scientist training pathways (STP, HSST) and Immunology curriculums.
- Hold fellowship of the Royal College of Pathologists in Clinical Immunology (by examination) and be currently employed as a Consultant Clinical Scientist.
